

**LAKESHORE SAIL CHARTERS, LLC
PASSENGER DRUG AND ALCOHOL POLICY**

LAKESHORE SAIL CHARTERS, LLC (“LSC”) is committed to providing a safe and enjoyable sailing experience for each of our guests. Our drug and alcohol policy allows LSC to meet this commitment. This policy is part of the terms and conditions of the charter, and each guest is expected to adhere to the policy.

A. Zero Tolerance of Illegal Substances. LSC does not permit the use of any illegal substance aboard its vessels. Any charter passenger engaging in illegal substance use will result in an immediate termination of a charter with no refund. LSC will immediately contact the Marine police authorities and other appropriate law enforcement authorities.

B. Alcohol Policy. LSC does not sell alcoholic beverages aboard its vessels. Guests are permitted to bring aboard a limited selection of alcoholic beverages for personal consumption. LSC is committed to a policy of safe and responsible drinking and accordingly, guests must adhere to the following rules:

1. Beverages must be in the original packaging and be either plastic bottles or cans. No glass containers are allowed, however, wine in the original bottle is permitted.
2. Beverages must be safely stored in shock resistant soft or small hard coolers.
3. LSC will assist with the storage of wine.
4. No mass containers of alcohol are allowed.
5. The consumption of alcohol may commence once all passengers have boarded the vessel and the vessel has moved from the dock. All alcohol consumption must cease fifteen (15) minutes before returning to the dock. Guests may not depart with open alcoholic beverages in hand.
6. Guests must arrange for their own transportation, either by hired transport or designated drivers, and are solely responsible for making such arrangements.
7. The quantities of alcohol brought aboard must be reasonable for safe and moderate consumption. It is the responsibility of the charter party leader to consult with LSC to determine an appropriate quantity. IT WILL BE AT THE CAPTAIN'S DISCRETION TO LIMIT QUANTITIES BROUGHT ABOARD if such quantity is deemed excessive, which decision will be in the Captain's sole discretion.
8. LSC reserves the right to confiscate alcohol on board and discard such alcohol without compensation if in the sole discretion of the Captain the consumption of alcohol is interfering with the safe operation of the vessel or disrupting other passengers.
9. Guests acknowledge the minimum age permitted for the possession or consumption of alcoholic beverages is twenty-one (21). The charter party leader or guest accompanying an underage guest agrees to supervise all persons under the age of twenty-one to ensure this regulation is not violated.
10. LSC wishes our guests to enjoy their gatherings and celebrations aboard our yachts. However, behaviors resulting from excessive alcohol use that disturb other guests or interfere with the safety of the vessel will not be tolerated. The Captain reserves the right to cancel a charter at any time due to unruly behavior of passengers. We ask that you respect fellow guests, respect the yachts and assist with a safe and enjoyable charter for all.
